This Amendment No. 3 amends and supplements the information set forth in the <u>Schedule 13D</u> filed by the Reporting Persons with the United States Securities and Exchange Commission (the "SEC") on March 19, 2010, as amended and supplemented by <u>Amendment No. 1</u> thereto filed on January 18, 2011 and <u>Amendment No. 2</u> thereto filed on October 23, 2019 (the "<u>Schedule 13D</u>"). All capitalized terms contained herein but not otherwise defined shall have the meanings given to such terms in the Schedule 13D.

Item 4. Purpose of Transaction.

Item 4 of the Schedule 13D is hereby supplemented by adding the following:

On September 26, 2019, LATAM Airlines Group S.A. ("<u>LATAM</u>"), a *sociedad anónima* organized under the laws of the Republic of Chile, entered into a certain framework agreement (the "<u>Framework Agreement</u>") with Delta Air Lines, Inc. ("<u>Delta</u>"), a corporation organized under the laws of Delaware, related to, among other things, the formation of a proposed strategic alliance between LATAM and Delta.

On the terms and subject to the conditions set forth in the Framework Agreement, on November 27, 2019, Delta launched a tender offer for 20% (and not more than 20%) of the issued and outstanding shares of LATAM, including shares represented by American Depositary Shares (collectively, the "<u>Shares</u>"), which expired on December 26, 2019 (the "<u>Tender Offer</u>").

The Reporting Persons participated in the Tender Offer, offering to sell 169,248,377 Shares (representing 27.91% of the issued and outstanding Shares as of September 30, 2019, as reported by LATAM in its Report of Foreign Private Issuer on Form 6-K, submitted to the Securities and Exchange Commission on November 13, 2019). On December 29, 2019, the results of the Tender Offer were published in Chile in the online newspapers *La Nación* and *El Líbero*, confirming that Delta had accepted 39,082,987 Shares tendered by the Reporting Persons (representing 6.45% of the issued and outstanding Shares as of September 30, 2019). On January 3, 2020, Delta paid \$625,327,792 (at a price equal to \$16.00 per Share) to the Reporting Persons for the acquisition of the Shares tendered by the Reporting Persons and accepted by Delta.

After the sale of Shares described above, the Reporting Persons are the beneficial owners of 130,165,390 Shares (representing 21.46% of the issued and outstanding Shares as of September 30, 2019), and, subject to the restrictions under the Framework Agreement as described in <u>Amendment No. 2</u> to this Schedule 13D filed on October 23, 2019, the Reporting Persons have shared power to vote or direct the vote of, and shared power to dispose of or direct the disposition of, all of such Shares.

Except as set forth above, none of the Reporting Persons has any plan or proposal which relates to or would result in any of the transactions described in subparagraphs (a) through (j) of Item 4 of Schedule 13D, although the Reporting Persons reserve the right to do so.
